1st Vice: North Island Tier 1 Program – goal is to have a competitive Tier 1 team.

VIAHA allows for out of association team tryouts. Challenge for Comox is geography as it is difficult in terms of distance for some communities to commute. Spoke with Campbell River and discussed a name change and the need for the program to be inclusive. A committee will be formed that will oversee the program and support the growth of the program. Hosted a parent information session last Friday. Will need to

figure out how to get ice for ID camps and solidify costs for the program. Governance falls under CVMHA. The program will have paid coaches.

Hockey ops meeting – have commitment from division managers for next season.
