**President:** Attended VIAHA meeting on Sunday January 15. There is a new board for Hockey Canada that will be in place for a year.

Al McCulloch is the VIAHA President and has received complaints from associations around the parent code of conduct not being followed at arenas – parents will be receiving a reminder of the parent code of conduct.

VIAHA is looking for a new North Island Vice President – requires someone who has hockey experience, an understanding of the rules, and has skills with technology. VIAHA AGM is being held on May 28 at the Nanaimo Golf Club

BC Hockey AGM is in Penticton on June 8-10. This is a great opportunity to connect with

There have been 25 match penalties or gross penalties – penalties from section 11.2 and 11.4 have went up substantially.

VIAHA is still trying to figure out the system for the U11 development playoffs.

Ken Miyoshi is the VIAHA VP of the Island League and is in the process of organizing the playoffs – reminder that teams will go back to their division for playoffs.

Brian Sugiyama is the BC Hockey Island Coach Coordinator for the island. Referee in Chief mentioned that there is a minor mentorship program – can apply for a BC hockey referee mentor to come out to mentor.

U7 and U9 are not on the referee pay schedule; the minimum pay for referees for U7 and U9 is \$20.

**Registrar:** Glacier Gardens sponsor boards have been cleaned up. Started to work on team snap for sponsorship and donations, however these are mostly for the United States.

Trevor has been doing a great job of keeping members updated on social media. AGM dates and location: May 17, 2023 at 6:30 – location to be announced. February 4 is the date for the delivery of the First Shift equipment – have 46 participants. Ice is booked for all sessions.

Bylaws will be deferred to the next meeting – executive committee and financial committee – both committees will be in place until May
