### Referee-in-Chief – Kevin Thompson

- Developing referee jersey loan program.
- Suggestion to add officiating interest checkbox to player registration forms.
- Working to attract and retain 15–17 year old officials.
- Exploring options for discounted referee gear.

#### 1st Vice – Luisa Perry

- Parent complaints re: bench shortening for competitive purposes—against Hockey Canada fair play mandates.
- Ongoing revisions to Division Manager Handbook.
- Discussion around siblings on ice—further clarity needed for liability concerns.
- Clarifications discussed:
  - o Bench staff course reimbursement for up to 6 members.
  - o CRC requirements for first aid responders.
  - o Removal of restrictions on advertising team fundraising events.
- Issues raised with team fund deposits at Credit Union.

- Few end-of-season player evaluations received from coaches. Discussion around how to ensure these are completed in the future.
- **Minimum team size** discussion: 14–15 skaters needed; decision to be finalized post-Labour Day.
- Dual roster policy raised—awaiting Female Coordinator feedback.
- **Equipment Purchases:** Pre-approval granted for jerseys, pucks, and first aid kits—order ASAP.
- Identified need for policy on paid programming and procurement specific to contracts
  - Power skating
  - o Goalie development
  - Female development

- Exploring jersey and banner sponsorships.
